USER REQUESTED MINOR USE LABEL EXPANSION of Pesticides on TURF and FORAGE SEED CROPS (Updated November 2023)

Pesticide tolerance trials on grass and legume seed crops are conducted by the Peace River Region Forage Seed Association, Saskatchewan Forage Seed Development Council, Manitoba Forage Seed Association and previously Alberta Agriculture and Rural Development. Trials are also conducted by the Pest Management Regulatory Agency (PMRA) if a product is selected through the Minor Use Priority Meeting held each March.

Consultation with seed growers and seed companies is done each year to determine what pesticides should be priorities. The majority of the work is with herbicides although some work is does include fungicides, growth regulators and insecticides. Data for specific forage species generated from trials is used to submit applications for URMULE (User Requested Minor Use Label Expansion) through the PPMUC (Prairie Pesticide Minor Use Consortium), Provincial Minor Use Co-ordinators and Pest Management Centre under AAFC (Agriculture and Agri-Food Canada). The efforts of these organizations has led to many URMULE on turf and forage seed crops since 2005.
